- ii) A Ph.D. Degree in concerned/allied/relevant discipline(s) in the institution concerned with evidence for published work and research guidance.
- iii) Associate Professor/Professor with a total experience of 15 years of teaching/research/administration in Universities, Colleges and other institutions of higher education.
- iv) A minimum score as stipulated in the Academic Performance Indicator (API) based Performance Based Appraisal System (PBAS), as set out in this Regulation in serial no iii for direct recruitment of Professors in Colleges.
