**ORDER:**

In the G.O. 2<sup>nd</sup> read above and in supersession of the earlier orders issued in G.O.Ms.No.74, YAT&C (Sports) Department, dated 09.08.2012 & G.O.Ms.No.8, YAT&C (Sports & YS) Department, dated 23.11.2020, Notification has been issued for implementation of three percent (3%) horizontal reservation for eligible meritorious sportspersons of Andhra Pradesh in Direct Recruitment without the requirement of competitive examinations, across Government Departments, Local Bodies, Public Sector Undertakings (PSUs) and Uniformed Services including the Police, Excise and Forest Departments. The said Notification has been issued with the concurrence of the Finance Department.

2. Keeping in view of the above Notification on implementation of three percent (3%) horizontal reservation for eligible meritorious sportspersons of Andhra Pradesh in Direct Recruitment without the requirement of competitive examinations, Government, after careful examination of the matter, have decided to make necessary amendments to A.P. State and Subordinate Service Rules, 1996.

3. Accordingly, the following Notification will be published in the Andhra Pradesh Gazette:-

**NOTIFICATION**

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India and of all other powers hereunto enabling, the Governor of Andhra Pradesh, hereby makes the following amendments to the Andhra Pradesh State and Subordinate Service Rules, 1996 issued in G.O.Ms.No.436, General

Administration (Services-D) Department, dated the 15<sup>th</sup> October, 1996 as subsequently amended from time to time.

### AMENDMENTS

In the said rules,

- (1) In Rule-2, for Definition-(19) “Meritorious Sportsman”, the following shall be substituted, namely:-

(19) Meritorious Sportsman: “Meritorious Sportsman” means a sportsman who has represented the State or the Country in a national or international competition or Universities in the Inter-University tournaments conducted by the Inter-University Boards or the State School team in the national sports / games for schools conducted by the All India School Games Federation in any of the games, sports mentioned below: and any other games / sports as may be specified by the Government from time to time:-

(2) In Rule-22, in sub-rule (2), for clause (d), the following clause shall be substituted, namely:-

**I. Guidelines:**

- a. The Recruitment of eligible meritorious sportspersons under three percent (3%) sports quota as horizontal reservation will be based on the Notifications issued by Andhra Pradesh Public Service Commission (APPSC) / Selection Board / Department concerned, without written examinations, and shall be appointed by the Department concerned, based on the final merit list approved by the State Level Committee.
- b. The three percent (3%) horizontal reservation in direct recruitment under sports quota shall apply to all the Government Departments, Local Bodies, Public Sector Undertakings (PSUs) & Uniformed Services, including the Police, Excise and Forest Departments.
- c. Criteria for deciding the eligible meritorious sportspersons: -
  - i. The sports disciplines mentioned at Serial No. VI of this order are the list of Recognized Sports Disciplines for the purpose of three percent (3%) Horizontal Reservation in direct recruitment.
  - ii. The eligibility criteria, based on the tournament & medals, for the Senior level competitions of sports for employment are listed at Serial No. VII of this order.
  - iii. For filling up of posts which are: -
    - a. under the purview of the Andhra Pradesh Public Service Commission (APPSC), the achievements (Individual & Team) of the meritorious sportspersons shall be considered as per the eligibility criteria indicated at Serial No. VII of this order.

- b. posts that are not covered under Group - I, II & III services under the purview of Andhra Pradesh Public Service Commission (APPSC), and those that are outside the purview of Andhra Pradesh Public Service Commission (APPSC) i.e., to be filled either by the concerned Department, or any Selection Board, or District Selection Committee (DSC), will be considered as per the priority as listed in Serial No. VIII of this order.
- d. The meritorious sportspersons must possess the requisite academic, physical standards, age limit criteria, prior experience, and technical qualifications, etc., as prescribed in the rules of the concerned department governing such posts, in Direct Recruitment.
- e. In respect of the posts related to physical education and sports training, such as Physical Education Teachers (PET), Coaches, the requirement of essential qualification(s) like Bachelor of Physical Education (B.PEd), Diploma in Coaching (NIS Regular) etc., will be temporarily relaxed for appointment under sports quota. This temporary relaxation is intended to strengthen the sports education and training in such institutions by the meritorious sportspersons. However, such selected candidates appointed under sports quota, shall acquire the required qualification, within a period, not exceeding five years from the date of appointment to such post.
- f. The three percent (3%) sports quota reserved for eligible meritorious sportspersons shall be filled in accordance with the priority criteria outlined in Serial No. VIII of this order.
- g. The meritorious sportspersons who are eligible for a particular category of posts, shall be considered as eligible for posts in lower categories also, subject to the fulfilment of specific conditions that shall apply to such posts but not vice versa.

Example: A sportsperson who is eligible for the posts in Group - I services will also be eligible for the posts in Group-II & Group - III services.

## **II. Role and responsibilities of the Recruiting Departments:**

- a. The concerned Department shall set apart such number of vacancies to be filled up by eligible meritorious sportspersons through horizontal reservation, without competitive examinations, and shall simultaneously communicate the same to the Sports Authority of Andhra Pradesh (SAAP).

- b. While communicating the indents to the Sports Authority of Andhra Pradesh (SAAP) for filling up of vacancies through direct recruitment under three percent (3%) horizontal reservation for meritorious sportspersons, the department concerned shall not assign roster points. They shall indicate the number of vacancies to be filled up, along with the beginning and the ending roster point of such vacancies.
- c. In case, the department notifies not less than 33 vacancies, it shall reserve one (1) vacancy for the eligible meritorious sportsperson. Similarly, if the number of vacancies is not less than 66, two (2) vacancies shall be reserved for the eligible meritorious sportspersons. Further, if the number of vacancies is not less than 100, three (3) vacancies shall be reserved for the eligible meritorious sportspersons. 33 1/3% horizontal reservation shall be applicable for eligible women meritorious sportspersons. This exercise shall be conducted duly following the 3% horizontal reservation for meritorious sportspersons.
- d. In the event, the number of vacancies notified by a department is less than 33, to meet the adequacy requirement that arises out of 3% horizontal reservation for meritorious sportspersons, the department shall communicate all the roster points from beginning till the ending roster points of such vacancies.
- e. Simultaneously, the Department shall communicate the remaining vacancies (other than sports quota) to the recruiting agencies / selection boards such as Andhra Pradesh Public Service Commission (APPSC) / District Selection Committee (DSC), for issue of notification to fill those vacancies by direct recruitment.
- f. In the event of non-availability of any eligible meritorious sportsperson for a particular post earmarked to be filled under the 3% horizontal reservation for the meritorious sportspersons, such post shall stand lapsed.
- g. A candidate appointed under sports-quota should be adjusted in the direct recruitment against the category viz. Open Competition / Three groups of Scheduled Castes / Scheduled Tribes / All groups of Backward Classes / Economically Weaker Sections, to which he/she belongs.

### **III. Role and responsibilities of Sports Authority of Andhra Pradesh (SAAP):**

- a. On receipt of the indents from the department concerned, to fill up the vacancies earmarked for the eligible meritorious sportspersons, the Vice Chairman and Managing Director, Sports Authority of Andhra Pradesh (VC&MD, SAAP) shall issue a

public notification in the leading newspapers (Telugu and English) in the state by inviting the applications from the eligible meritorious sportspersons for the posts. The details of vacancies, qualifications, and other terms and conditions shall be mentioned in the said notification.

- b. The forms in which the applicant shall submit his meritorious sports achievement, along with her / his application, shall be as notified by the Youth Affairs, Tourism & Culture Department.
- c. In response to the notification, all the applications received by Sports Authority of Andhra Pradesh within the stipulated time, shall be scrutinized by the Screening Committee constituted for this purpose. The composition of the Screening Committee shall be as follows :-

Any other member may be co-opted as deemed fit by the Chairman.

- d. The Committee shall undertake the following :-
  - i. To verify as to whether the certificates have been awarded by a competent authority as specified in Serial No. IX of this order.
  - ii. To ascertain the genuineness of the documents from the issuing body.
  - iii. To assess the level at which the applicant has participated (e.g., State, National, or International).
  - iv. To verify the medals / participation in the competitions / place achieved by cross verification of additional documents such as photographs, official notices, press releases of the event, participants involved, and line up certificates.

- v. The date of birth, as mentioned in valid certificate produced by the applicant, shall be tallied proportionately to the category of age group vis-à-vis the concerned sport.
- vi. The date of birth shall be determined as follows :-
  - a. If a Board such as Secondary School Certificate (SSC), Central Board of School Education (CBSE), Indian Certificate of Secondary Education (ICSE) etc., awards a certificate, the date of birth (DoB) mentioned in the certificate should be considered valid.
  - b. In the absence of certificate issued by a Board, the certificate issued by the competent authority of the “School” only i.e., schools run by autonomous organizations like Kendriya Vidyalaya Sangathan (KVS), Navodaya Vidyalaya Samiti (NVS), Central Tibetan Schools Organisation (CTSO), Sainik Schools Society etc., which are not affiliated to Central Board of School Education (CBSE) but are recognized by the respective State Education Departments shall be accepted as proof of age. The certificate issued by any Sports Association or other body will not be accepted as valid proof of age.
- vii. The personal credentials of the sportsperson provided on the application, birth certificate, and the sports certificate shall be the same.
- viii. To verify as to whether the organization that issued the sports certificate is recognized by the appropriate sports governing body. Certificates from unrecognized or unaffiliated organizations shall not be considered valid for employment purposes. The said certificates shall be considered as invalid.
- e. The Screening Committee shall prepare a preliminary merit list, and it shall be published in the official website of Sports Authority of Andhra Pradesh to invite objections, if any, within 7 days from the date of publication.
- f. All such objections received within the stipulated time shall be examined by the Screening Committee, and disposed of, duly recording the reasons within the stipulated time.

- g. The Screening Committee shall prepare a preliminary merit list of the eligible meritorious sportspersons against the number of posts to be filled according to the horizontal reservation.
- h. The Sports Authority of Andhra Pradesh shall complete the process of finalizing the merit list of eligible sportspersons within 30 days from the last date of receipt of applications, as specified in their Notification, from the interested eligible meritorious sportspersons.
- i. The merit list shall be communicated by Vice Chairman & Managing Director, Sports Authority of Andhra Pradesh to the State Level Committee (SLC) immediately.

#### IV. Role and responsibilities of State Level Committee

##### Composition of State Level Committee (SLC)

- a. The composition of the State Level Committee shall be as follows:
  - i. Chairman : Special Chief Secretary / Principal Secretary / Secretary to Government, YAT&C (Sports & Youth Services) Department.
  - ii. Member : Special Chief Secretary / Principal Secretary / Secretary to Government (Services & HRM), General Administration Department.
  - iii. Member : Special Chief Secretary / Principal Secretary / Secretary to Government of the concerned Recruiting Department.
  - iv. Member-Convener: The Vice Chairman & Managing Director, SAAP, A.P., Vijayawada.
- b. The Vice Chairman & Managing Director, Sports Authority of Andhra Pradesh shall convene the State Level Committee meeting immediately on receipt of the preliminary merit list and place the said list before the State Level Committee.
- c. The State Level Committee shall review the department-wise, cadre-wise vacancies earmarked to be filled under the 3% horizontal reservation for the eligible meritorious sportspersons.

- d. The Committee shall review the preliminary merit list, as submitted by the Screening Committee, to satisfy itself that the list has been prepared in accordance with the rules stipulated for this purpose.
- e. The Committee shall complete the exercise within a time period, not exceeding 15 days from the date of receipt of the preliminary merit list from Vice Chairman & Managing Director, Sports Authority of Andhra Pradesh.
- f. The final merit list of eligible meritorious sportspersons for each of the earmarked posts will be approved by the State Level Committee (SLC) and such list shall only be valid for that specific notification.
- g. The approved final merit list shall be communicated by the Convener of State Level Committee, to the Recruiting agency such as A.P. Public Service Commission / Selection Board / Department concerned / District Selection Committee.
- h. The Recruiting agency shall integrate the final merit list, communicated by the State Level Committee, of meritorious sportspersons for implementing the horizontal reservation in their merit list.
- i. The final merit list approved by the State Level Committee shall be final.

#### **V. Other guidelines and general conditions**

- a. Participation at a higher-level tournament shall be considered only when it is supported by winning medals at the lower-level tournament for Individual events only. For Team games, participation at a higher-level tournament shall be considered, atleast, when it is supported by participation (not winning medal) at a lower-level tournament. For this clause, participation certificates, as applicable, need to be produced by the candidate.
- b. If, at any point of time, it comes to the notice of the Competent Authority, that a sports certificate was issued fraudulently by any Sports Association/Federation, necessary legal action against such Sports Association / Federation shall be taken.
- c. Forms issued by Sports Federation/Associations, other than those recognized by the Ministry of Sports and Youth Welfare, Government of India / Sports Authority of India / Sports Authority of Andhra Pradesh, shall not be considered.

- d. Sportsperson recruited against sports quota shall be terminated from service, if the information and documents furnished by him/her for recruitment, are found to be invalid /fake / obtained by fraudulent means, at any stage, as per the rules in vogue.
- e. Every candidate, at the time submitting his application, shall be required to submit a declaration in the prescribed format that all the documents filed as a part of his application are true to the best of his knowledge and belief and further that such candidate shall be liable for criminal / disciplinary action, if a violation is noticed by the competent authority.
- f. The candidates appointed to a Department under sports quota, shall represent such Department for at least 10 years from the date of appointment in sports competitions to be conducted at State, National and International levels.
- g. The eligible meritorious sportsperson should have represented the state of Andhra Pradesh in the National and Sub-National level tournaments.

The following criteria shall also be taken into consideration in determining the priority list.

- a. Priority will be given based on the level of sports achievement as per priority list prescribed at Serial No. VIII for the best achievement made by the sports person during the eligible period.
- b. In case, two candidates achieve the same priority based on above criterion, the sports person who is elder in age shall be given priority.
- c. In the event that two candidates secure the same priority and also share the same date of birth, the candidate whose sports achievement in the same category was obtained earlier shall be given preference.
