Dr.B.R. Ambedkar University, Srikakulam, Etcherla is inviting sealed tenders quoting highest offer for **Mango and Cashew usufructs** of bearing trees In Dr. B.R. Ambedkar University campus for a period of six months from 31.03.2026 to 31.08.2026.

The competitive tenderer has to quote highest offer on the Format (available in Administrative Office) duly indicating highest offer along with **Rs.10,000/- (Rupees ten thousand only)** as E.M.D in the form of **Demand Draft to be drawn in favour of "Registrar, Dr. B.R. Ambedkar University, Srikakulam"** and drop the sealed cover in the tender box which is kept in the Administrative Block on or **24.03.2026**.

The tender box will be sealed at 3.00 P.M in the presence of tenderers who are present on 30.03.2026 and the box **will be opened on 31.03.2026 at 04:00 PM.** before the tenderers who will be present. After opening the tender box all the tender forms will be signed by the Committee and Highest Offer will be considered to award the Usufructs. The EMD amount Rs.10,000/- will be adjusted in the highest offer amount. The successful tenderer shall pay the offered amount at one-time within one week immediately after the tender process is completed.

The EMD DDs. of unsuccessful tenderers will be returned on the spot to the concerned duly taking proper acknowledgement.

The successful tenderer is to protect the University property including the trees which were tendered for lease. The University has reserved the right to cut and remove any obstruction of tree/trees from the leased area in the leased period for undertaking any construction or development work in the campus.

The University has also reserved the right to cancel/reject the tender either in part or full without assigning any reason. The University staff and their family members are not entitled to participate in the tender either directly or indirectly.
